

HELLO NEIGHBORS SOCIAL COMMITTEE MEETING NOTES

March 4, 2016

Attending: Wendy, Pat, Denny, Nancy, Patricia, Barbara, Valerie, Carolyn, Ginny, Peggy, Elsie

Announcements: Denny asked if 1) anyone would be able to pick up donated bread from Costco on Sundays to share with the community. Daryl Unruh has been responsible for doing this, but his health prevents him from continuing to do so, and 2) the KCCA Board of Directors is accepting applications from residents who wish to run for the position of Director. There will be three positions open. Applications are available at the KCCA office.

Next BYOB beverage event: Scheduled March 10, 2016 from 5pm to 7pm in the Banquet Room. Decorations provided by Wendy were reviewed and soundly approved. Denny reported that he may not be able to attend, but will provide food as promised. Nancy will provide shamrocks to place on committee members' name badges. Wendy will lead a trivia game at which winners will receive silly inexpensive prizes. Refreshments will be provided as determined the last meeting.

Pies of March: Scheduled March 20. Helpers should plan to be there at 12:30. Jim Trees and Adele Coverdale will scoop ice cream.

Discussions:

- Peggy and Nancy suggested that the first meeting of each month be devoted to planning and organizing the month's BYOB event and the second to social events and new resident orientation meetings. The group approved this.
- It was pointed out that the HNSC events calendars which were distributed featured HNSC meetings every other Friday rather than the first and third Fridays of each month as initially planned. The group agreed to meeting every other week.
- It was agreed to use the Banquet Room rather than the lounge on a trial basis, at least until the fire door is installed. The Fire Marshal requires occupancy not exceed 49, but with the fire door in place, 99 people would be allowed per Denny. The Banquet Room would allow more movement for games and

dancing, etc., but noise may be a problem. Comment cards will be revised to reflect the change of venue.

- It was agreed that, if door prizes are planned, a raffle ticket will be given to each attendee. Additionally, the 50/50 tickets would be available for purchase as usual.
- It was decided that compensation for musical entertainment at events be determined on an individual basis. \$50/hour with \$100 total per event and gift cards were suggested. Denny will ask KCCA Finance Committee to approve the expenditure of \$100 monthly toward KCCA social events. The “tip jar” specific to the musical group will continue to be provided near their location.
- It was agreed the “donations jar” will be eliminated since admission is now being charged.
- Wendy provided on-line information and the group was enthusiastic about aprons that could be ordered and used by HNSC members at events. The cost is \$50 for 12 aprons. Selection of color and logo placement will be determined.

Treasury Report: There is \$472.55 in the bank. \$42.18 is in petty cash. KCCA was charged for recent orientation meeting costs.

New Business:

- Peggy reported that the Men’s Golf Club will host the Home’n’Home golf tournament here June 2, 2016. They would pay for the HNSC to provide a BBQ lunch at the event. The group agreed to do so.
- Nancy will revise BYOB event comment cards to ask only, “Did you enjoy yourself?” And “Suggestions”.
- Events planned for the year will be publicized by providing a schedule in the next “Newsletter”.

The next meeting is scheduled March 18, 2016 at 9:30a.m.
