Board Business:

We started 2022 much more hopeful than 2021. COVID took a huge toll on our operations and standard routines. The good news is we are starting to recover. Clubs are re-grouping and becoming active again. Events are being scheduled. Attendance and interest appear to be up.

We our looking again at the crucial improvements needed for our fixed assets and are starting to let out contracts on some things within our budget. Jeff Halfman, our Golf Course Superintendent, does an amazing job getting every ounce of life out of our equipment



and facilities. But even those have an end of life and need replacement and/or repair. You will see a few crucial things happening here and there, many of which have been deferred over the past years. Current items include a new mower, tractor, the pond dredging, a new fence, roof repair to the pump station and painting.

The indoor pool remains a concern for all of us. As much as we may want to use the pool, we don't want to jeopardize the litigation outcome and must stay the course. For the outdoor pool, we will be looking to engage an engineer to help us assess future repairs.

This year we will also be taking a hard look at our cash reserves with a Level 1 Reserve Study and an even harder, well thought out and well-considered look at how we are organized and what our management structure should be. All the above are big projects- not to be undertaken lightly, done randomly or quickly – for the Board *and* the Community.

The Buzz About HOA's

HOA's & Pesticides

HB2409 took effect as of January 1, 2022. Summary: Prohibits HOA's from requiring application of pesticide on owner's property **except as necessary for ecological or public health**. Requires association to notify owners, **upon the owner's request**, prior to pesticide application on owners' property.

An association may not require an owner to apply a pesticide and shall allow any owner to exclude the owner's property from the landscaping activities of the association that include application of a pesticide, except to the extent a pesticide or other pest management practice is necessary to manage or prevent a pest issue that could harm ecological or public health.

Gardens, Chickens & Bees

HB3322 would have required HOA's to allow residents to grow gardens, raise hens and keep bees.


Supporters of House Bill 3322 said it would give people in planned communities the opportunity to raise their own food.

But opponents, including Sen. Lee Beyer, D-Springfield, said the bill would subvert the will of people who joined those communities to avoid things like chickens and bees.

"People make choices about where they live," he said. "Some people want to live in a planned community that's very dense, and that doesn't have animals of any kind. And I think that's a reasonable choice."

The measure fell two votes short of winning approval and is now dead for session.

Who is Required to Pay Assessments?

This is a summary explanation and the CC&R's. Simple answer, we have Owner-members and Residentmembers. Owner or Owner-member shall mean the person(s) who owns the Unit or Lot. A Resident-member

shall mean any person living in a Unit who complies with the provisions of Article III of the CC&R's. FHA Standards within Article III. persons under 18 are not permitted to be residents and at least one resident of each Unit must be 55 years of age or older. Residency is any person,

including a caregiver or temporary custodian, who resides in a Unit for more than 60 days in any consecutive 12-month period is considered a Residentmember. **Owner-members** and Residentmembers are subject to Association Documents and assessments. Persons under the age of 18 years may not visit for more than 60 days during a consecutive 12 month period. Each Ownermember is deemed to

covenant and agree for himself and Resident-member of his Unit to pay to the Association all Regular, Special and any Individual Assessments in respect to each Unit or Lot owned. (From CC&R's Article III and V).


Section 9 A, Rental Units see CC&R Amendment 2017-018368. No unit may be rented and must be permanently occupied only by an Owner or immediate family member of the Owner. Exceptions to this are listed in CC&R's Article VII, Section 9, B - E).

When it is noticed that a Residentmember is living in a Unit who is not listed on the last Assessment Affidavit (the one you sent in with your yearly assessment), correspondence from KCCA is sent to inform the Owner-member of the violation. In CC&Rs Article VIII Enforcement of Restrictions procedures are explained. The Association shall employ an attorney to enforce the provisions of the Association Documents against any owner-Member, the prevailing party shall be entitled to reasonable attorneys' fees and costs in addition to any other sums due as provided herein. Prior to the attorney, the Association will use correspondence, Owner-Member presenting their side of the situation. Fines may be leveled to help resolve the situation.



Treasurer's Comments

Less than a handful of the community members had some suggested revisions about the motion that was passed at the 12/14/2021 BOD meeting regarding utilizing sweep. The following comments should answer the questions.

With over 50 years' experience in financial field, when I am making a decision specially one that involves other people's money, I research, talk to the financial institutions, bank managers and even the CPAs including the one who is auditing and filing KCCA's taxes, to ensure an informed decision is made.

Let's start with some acronyms:

The FDIC (Federal Deposit Insurance Corporation). An independent agency of the United States government that protects bank depositors (Up to **\$250,000**, per depositor, per FDIC-insured bank, per ownership category) against the loss of their insured deposits in the event that an FDICinsured bank or savings association fails. FDIC insurance is backed by the full faith and credit of the United States government.

How much deposit insurance coverage do I qualify for?

Lisa: "Sorry, this took so long. I was waiting for a response from our DDM Vendor. The limit is **\$50,000,000.00** per customer."

Considering the combined reserves account balances was \$767,041 we were in violation of CC&Rs Article VI Sections 1 and 3.H; ORS 94.670; ORS 94.595; 2012-404 Secured Funds Policy.

In conclusion, the motion that was passed at the 12/14/2021 BOD Meeting satisfies the fundamental financial requirement and protects KCCA funds. The information within the Treasurer's Comments above should satisfy questions and/or concerns.

Yard Lamps Submitted by James Minor LARC chair

Yard lamps are a replacement for street lights and are used by members to see the area around them, for safety and to help prevent unwanted

people from wandering in your area.

Things you might not know about the yard lamps in your front yard.

1. You are responsible for your yard lamp. (Check with your sub association HOA, this may not apply)

- 2. Lamp posts are required.
- 3. Lamp posts must be between 4 and 6 feet high, black or white to match the lamp.
- Photo cells or required equivalent are required for on/off light operation.

- Bulbs must produce at least 800 lumens (equal to a 60-watt bulb) and must be white or clear, with seasonal exceptions. Having a light with too many lumens will disturb your neighbors.
- 6. Lamps must be lit during hours of darkness.
- 7. Burned out bulbs must be replaced within 24/48 hours.
- Foliage can grow up the post as long as the light is not blocked or covered.

It is important for yard lamps to be operational, so be prepared to receive a notice if your yard lamp is out.
