

HELLO NEIGHBORS SOCIAL COMMITTEE MINUTES
October 14, 2022
The meeting began at 2:55 p.m.

Mission Statement

“Hello Neighbors Social Committee’s purpose is to enable the KCCA community to engage in warm and welcoming social activities while maximizing residents’ involvement, initiating interactions and building new relationships.”

Attending: Jim Minor, Peggy Trees, Ron Yates, Dennis Williams, Terri Johnson, Pat Rigby, Sherry Smith, and Mary Lou Russ

Treasurer’s Report:

- Rosemary sent the attached record of expenses from January 1, 2022 to 9/21/22.

Budget:

- Peggy said about \$767 of the initial \$1,000 has been spent. Jim said he has requested information on the balance and will ask for additional money if the committee needs it.
- Per discussion and returning to past practices, each meeting in the future will include a budget report.

Community Birthday Party:

- Peggy said the photographs which Rosemary took and sent to her show excellent decorations and happy participants.
- Terri and Pat said people were smiling and happy as they came into and left the event. They estimated that 50-55 people attended.
- Jim noted that participants, especially one man, were very helpful in putting away chairs after the event.

New Resident Meeting (11/06/2022, 2 pm):

- Peggy confirmed that Terri and Dennis will welcome participants and that she and Pat will lead the meeting.
- Pat confirmed and agreed to schedule the meeting room with the KCCA office for 2023 New Residents Meetings at 2 pm on the first Sundays of February, May, August and November.
- Peggy will take care of prizes and use the umbrella that Terri found in with supplies.

- Pat would like more men's golf passes to put into folders. These and women's passes give new residents a free round of golf plus an invitation to join and contact information for the golf clubs.
- Peggy asked if there is anything else to add to the packets. Jim shared that the CC&R's are being updated to be consistent with OR law about biases and that the way to pay KCCA assessments will change from once a year to once, four time or ten times.
- Peggy said this and any other new information can be added to the New Residents packets.
- Pat showed the new packet label which credits the HNSC will delivering the packets and explained that she took advantage of a sale to order 50 green folders for packets at 27 cents apiece.
- Peggy asked Jim if KCCA has a business account for supplies that would cover this type of expense, and they asked Peggy to submit her receipt for the folders for repayment.

Story Telling (11/14/2022, 1:30-3 pm):

- Sherry Smith questioned the time, initially thinking it should be 2-4 pm, but checking resolved that the 1:30-3 pm time advertised in the Newsletter is correct.
- She explained that the idea is for participants meet in the lounge to tell a story, true or not, taking turns talking for about 5 minutes.
- Ron will providing cookies for the event, and beverages will be served.

Movie Time (3rd Friday each month):

- Dennis and Terri thanked Ron for supplying popcorn.
- They described the film for October, *Begin Again*, and announced that the selection for November will be the sequel to *Top Gun*.

Christmas Party (12/17, 6-8 pm):

- Plans for the party elicited a great deal of discussion as food, selling tickets, and types of activities were considered as were legal guidelines about room capacity and the participation of people who are not KCCA residents.
- Rosemary Dutra was called and she contributed her ideas.
- The conclusions are that the party will use both the ballroom and lounge with set up and take down times included in the room reservations.
- Ron proposed a new table arrangement for the ballroom to maximize the space for participants and activities.
- Food will be set up in the lounge.
- Tickets will be sold—\$10/person—by Teri Jensen, in the KCCA office and by committee members who will turn the money into Teri.

- The event will include appetizers and desserts provided by HNSC members; guests will bring their own beverages.
- Ron will prepare a flyer for Rosemary to submit tonight for publication in the November newsletter.
- Ron will also provide background music for the event.
- Members of the recently formed Garden Club, who have contacted Sherry about this, will make centerpieces for the tables.
- Ron and Rosemary will provide tablecloths.
- Raffle tickets will not be sold. Instead, a random system to give out prizes, probably a take off on game shows such as *Let's Make a Deal* and *The Price Is Right*, will be finalized at a future meeting.
- The cake walk, very popular last year, will be another activity, with Dennis leading all.
- The party will include the popular 50/50 raffle.
