New Resident Meeting (11/06/2022, 2 pm):

- Peggy will lead the meeting.
- She gave Pat copies of the KCCA Members' Handbook to use in packets for new residents.
- Pat said she has received 7 RSVPs, so about 15 people are likely to attend.
- Elaine will be there from 2-3 pm to help conduct tours, and she will bring wine to use for gifts.
- Terri and Dennis will welcome participants.

Movie Time (3rd Friday each month):

- Dennis and Terri solicited suggestions for the December movie which has not yet been selected.
- Jim recommended the 1988 film, Scrooged, with Bill Murray.
- The selection for November will be Top Gun: Maverick.

Story Telling (11/19/2022, 1-3* pm):

- Sherry Smith noted that a Community Conversation is scheduled at noon on the same day in the Ballroom.
- *The newsletter calendar shows that Story Telling will begin at 1 pm, but the article about the event and the article about upcoming KCCA Events both show a starting time of 1:30 pm.

Budget:

• Jim announced that the BOD has approved a budget on \$3,500 for the committee in 2023 based on the agreement that the committee will provide a detailed accounting of expenditures, the committee's standard

procedure. He also said that a new 4' x 8' plexiglass display case for outside the main clubhouse entry will be installed in the new year.

Christmas Toy Drive (11/4 - 12/4, 2-4pm):

•Peggy asked if the committee would be interested in helping with a Christmas toy drive for children, infants to age 12, from Shriners Hospital, Doernbecher Children's Hospital, Children's Cancer Association, Down Syndrome Network of Oregon, and United Cerebral Palsy.

- •The gifts will be distributed by Mr. and Mrs. Clause at a Christmas Buffet in the Banquet Room on December 11, 2-4 pm.
- •The committee agreed. A collection box will be in the Clubhouse entry from 11/4 to 12/4 and gifts can be dropped off in person on 12/4 from 2-4 pm. Peggy, Terri and Dennis will be on hand to accept donations.
- •Mary Lou will ask Terri and Pam to send an email blast and a message to KCCA club leaders to publicize the event.

Christmas Party (12/17, 6-8 pm):

- •Sheri and Ron have both bought tickets for the party and their understanding is that, including their purchases, Teri has sold at least 23.
- •A poster advertising the party is in the Crown Room, and, although it was not easy to find, in the Clubhouse Living Room. Ron will make a border for the poster in the Living Room and put it on an easel to increase its visibility.
- •Discussion about the number of guests ensued with the conclusion that 100 tickets can be sold and still leave space for drop-in participants.
- •Ron is designing a floor plan for the tables in the banquet room that will leave the center of the room open and maximize space for games.
- *Dennis is still planning games; he will emcee the party.
- •Ten prizes will be available for game winners:
 - •Ron will bring 4 bottles of wine and a wrapped plate of cookies.
 - •He will also canvas for donations from participants in the Lions Club Holiday Bazaar held November 12 in the Banquet Room.
 - Elaine will bring two coffee cards.
 - *Terri and Dennis will bring a cookie jar and plate set.
 - •Sherri will bring two poinsettias.
- •Peggy will check with the new garden club president to learn more about the centerpieces club members will make for the tables.
- •Food for the party can include hot appetizers because Ron will provide chafers to keep the foods warm. He will also bring extension cords.
- *Set up will begin at 3 pm, and Peggy will call a couple of people to help set up the tables and chairs.
- *Since participants are buying tickets, no donation jars will be used.
