The election timeline for the recall dates. *The Bylaws Article II section 3. Special meeting*. A special meeting shall be called by the President or by a majority of the Board, or upon receipt by the Board a written request signed by at least one hundred (100) Members. Such a special meeting shall be held at a date and time fixed by the Board not less than thirty (30) or more than sixty (60) days after the meeting is called by the President or Board or receipt of the request.

Section 4. Notice of a special meeting shall be given not less than ten (10) nor more than sixty (60) days before the date of any meeting at which Members are required or permitted to take any action.

The Board received the petition on the 14th day of November therefore the date was called by the Board and the Special Meeting was set in accordance with the Bylaws for January 12th, 2024; in the KCCA Clubhouse at 6:00 pm. At this time Melanie is allowed to speak on her behalf.
